Hi Bond Rees,

we're looking to locate a Julie Jackson, who is named on the attached land registry (final paragraph) as having been married to John Terence Jackson, and as living, on 14 March 1983 at 14 Oakroyd Drive, Bracken Road, Brighouse, W Yorkshire.

We need one of:

1. *A death certificate of Julie Jackson.*
2. *The Decree Absolute or nullity of her marriage to John Terence Jackson.*
3. *A copy of the Court Order ending the Home Rights.*
4. *A Presumption of Death Order or Separation Order relating to the relationship, or*
5. *A form signed by Julie Jackson using a standard Land Registry form*

If you can locate one of 1-4, or find Julie Jackson do we can approach her, that'd be fantastic.

I've attached copies of a death certificate and probate certificate for a Julie Jackson, who could have been the right age, and lived in the right town, but who I can find no record of having been married to a John Terence Jackson. Her maiden name was spencer and she was born in Rossington

REPORT

Many thanks for your recent enquiry. After numerous investigations, we are now in a position to report the following details.

Identification

In this case, we have not been able to reliably identify the subject's data.

This is due to the lack of a marriage record. Sweeps of the English, Welsh and Scottish Marriage indexes show no legally recorded marriage between John Terence Jackson and Julie Jackson.

As we have no birthdate or maiden name for Julie Jackson a thorough process of elimination has been conducted. All plausible matches in and around the West Yorkshire area have now been examined and discounted. Widening this sweep will take considerable time.

We suggest that we undertake a search for the divorce record. This is possible but it will need an additional budget and time. We are aware that the case is time-sensitive. The entire application can take 4-8 weeks to complete.

We can speculate several plausible scenarios.

- The Marriage was conducted offshore.
- The marriage was not legal.
- The marriage was under a different name.
- The Title has an error on the name data.
- The marriage record has been lost.

As we have not confirmed the marriage, and we have discounted a plethora of plausible candidates, we must now concede that the data is not forthcoming.





Summary

As discussed, applicants for a copy of the divorce record will require time and budget. In our opinion, this search should be conducted.
